

Why Employment Verification? Why this topic?

- Importance of Employment Verification
 - Confirming accuracy
 - Ensuring skills and experience
 - Preventing fraud
 - Mitigating risk
 - Identifying gaps in employment of fabrication of titles
 - Understanding the reason for resignation
 - Compliance FCRA, HIPPA, etc.
 - Preventing discrimination
- Rising access fee to The Work Number
 - \$19.95 in 2019 / \$95.92 in 2025
- Decision = Cost vs Turn-Around Time requirements vs Data collected





Avoiding additional Risk...

 Verifying applicant provided contacts
 ID Verification Services

RSI Employment Verification - 2024

If the applicant has not provided RSI employment verification proof, we source The Work Number first.

- Study of RSI Employment Verification performance
 - Last 20k+ verifications
 - The Work Number = 40%
 - Calls to employers = 50%
 - Other Third-Party = 10%
- Decision = Cost vs Turn-Around Time requirements vs Data collected





Typical workflow - RSI Software

- Order is sent to RSI via a "package" of services or a single Employment Verification order.
 - The order most likely includes last 3 employers and applicant personal data.
- RSI sources The Work Numbers "Employment Data Report ALL"
 - The Work Number will return all results on file, if any
 - Any time results are found on TWN, RSI will pass through the fee of \$95.92
- RSI will verify applicant submitted data vs The Work Number Results
- RSI will contact any outstanding employers not found on TWN
- RSI will close the order and send the completed report
 - Typical TAT 48 hours or less





Why use The Work Number?

Equifax owns The Work Number and claims to have over 50% of the "employer businesses" in their database.

- **TWN** claims
 - 10% more data since July 2023
 - 3.4+ million employers contribute to their data
 - 6.1m employer businesses
 - 26.5m non-employer businesses
 - Source: Small Business & Entrepreneurship Council
 - 695m+ records
- Same Day TAT
- Beginning January 1st, the rate increased from \$87.20 to \$95.92.
 - This is an RSI negotiated discount
 - Normal rate is \$119









Alternatives using RSI "Required Forms"

- With our QuickApp technology, applicants receive a text or email to input personal data and sign authorization forms
- Daily reminder emails to applicant
- RSI can add "Required" documents in the Applicant Portal

1. The Work Number – Employee Request

RSI can add a required document request

- Employee submit their own The Work Number report
 - Individual reports are free
- Log in to the employee section of the The Work Number website or call the employee service center at (866) 222-5880
 - This report is called an "Employment Data Report" (EDR)
- Considerations...
 - How long will it take for the <u>applicant</u> to process the order and return it to RSI?









2. IRS Form 4506-C

(IVES)Income Verification Express Service

- Request Federal form 4506-C authorization to release <u>tax records</u>
 - Form 4506-C prefilled with RSI info
 - Add Personal data
 - Electronic Signature
 - 3 Day TAT once received from applicant
 - Fee for 3 yr. data Approx. \$35
- Considerations...
 - Form will be available to the applicant in the RSI portal.
 - Reduced cost from The Work Number.
 - How long will it take for the applicant to process the form?
 - Data does not provide exact employment dates.
 - Will provide additional income information for verification if needed.







3. Required form – W2

RSI can add required documents for the applicant to submit to RSI when using our Quick APP / Applicant Portal process

- Request a copy of all W2's or IRS Transcripts for the desired time-period
- Considerations...
 - Does the applicant have the W2's readily available?
 - Can they access IRS.gov for transcripts?
 - Transcripts show limited employer data
 - How long will it take for the applicant to upload docs?
 - Does not provide exact employment dates
 - No additional third-party fees

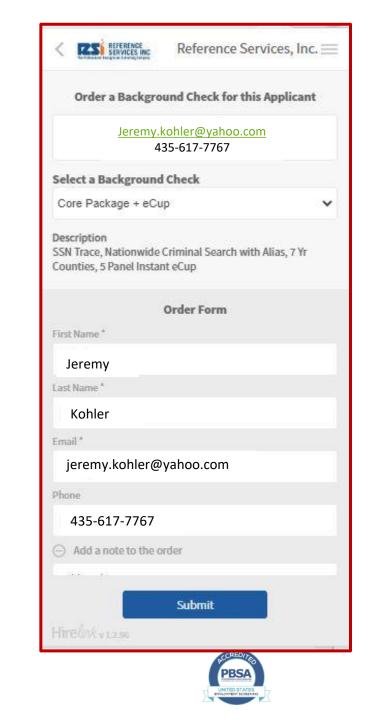

RSI Chrome Extension

- 1. Add applicant name
- 2. Select background screening custom package
- 3. Select work location system supports multi-location child accounts, if needed
- 4. Submit
- System then sends Quick App email / text from the RSI system to applicant to capture personal data and authorization forms



Key Takeaways



- Employment Verification plays an important role to onboarding new employees
- The Work Number claims to source over 50% of the "employer business"
- The Work Number fee is increasing annually
- There are alternative to TWN but must consider TAT and data retrieved
 - Personal Work Number report, free to applicant
 - IRS Form 4506-C
 - W-2
- Lots of Integration options
 - RSI Chrome Extension
